APPLICATION FEE : R600

This is payable on submission of an application form for a place in the school. It is non-refundable and covers the cost of administration and assessment.

PLACEMENT FEE : R12 000 (Pre-Reception to Year 12)

This is payable on acceptance of a place in the school. It is non-refundable and is applicable to children enrolling in Pre-Reception through to High School prior to commencing at the school.

REFUNDABLE FOREIGN STUDENT DEPOSIT: R 20 000

Beginning 1 January 2025, foreign students will need to make this payment upon placement. This fee will be refunded when the student leaves our school. The deposit will not be required if fees are paid in full for the year in advance.

TUITION FEES:

Parents have a choice of the following payment options:

- Annually: paid in full (in advance) into the school's bank account
 - By 31 December 2024 – at a discount of 3.5%
 - Failure to settle the fees by the 31 December, will result in the annual discount not being applicable. The discount will be charged back onto the student account.
- Termly Payments:
 - Payments are due quarterly on the first working day of January, April, July, and October 2025, either by direct payment or PayGate.
 - If the due date falls on a public holiday or weekend, the debit order will be processed on the next business day.
 - If an account falls in arrears for over 30 days, a mandatory debit order will be required by the School. Also further terms and conditions apply as per enrolment contract.
- Monthly Payments by Debit Order:
 - Debit orders will be processed monthly over the first 10 (ten) calendar months, starting on 1 January and continuing on the first banking day of each subsequent month to 1 October 2025. If the 1st falls on a public holiday or weekend, the debit order will be processed on the next business day.
 - Debit orders are **mandatory** for all monthly payments.
- Sibling Discounts: The eldest child is charged at the full fee rate. The second sibling 5% and the third sibling 10% discount on their fees, while the fourth sibling receives a 30% discount.
- A late payment penalty will be applied if tuition fees are not paid in full by the 7th of each month: R500 for monthly payers and R1500 for termly payers. The penalty will be charged on the 8th of the month. If the account remains unsettled 30 days after the invoice date, the student will be suspended until all overdue balances are fully paid.
- A R500 administrative fee will be applied to any debit orders returned due to insufficient funds or other issues.
- Parents or guardians must provide written notice to the Head of School at least one full school term in advance if they wish to withdraw a student. If notice is not given, a fee equivalent to one full term's tuition (at the applicable rate) will be charged in lieu of notice.

LATE PICK-UP FEES

- Families will have a 5 minute grace period for pick-up from both school and aftercare programmes.
- After 5 minutes a fee of R120 will be charged.
- After 20 minutes the full casual care fee of R190 will be charged instead.
- After 18:00 a fee of R120 will be charged for every 20 minutes period.

ADDITIONAL COSTS:

The following costs are not included in the current School Fee Structure and remain the responsibility of Parents/Guardians:

- School tours, camps, extra-curricular activities, uniforms and stationery.
- Textbooks must be purchased before school commences.
- Workbooks are ordered through the school account.
- IGCSE exams for Year 10 are charged at £85 per subject invoiced in September 2025.
- AS level exams for Year 12 are charged at £95 per subject invoiced in September 2025.
- A-level exams for Year 13 are charged at £95 per subject invoiced in September 2025.
- A-level (Year 13) non-refundable placement fee of R4 500 will be payable by 1 January 2025.

These costs cover Cambridge fees, invigilation, postage and courier services. Parents will be billed as per rate on the day of foreign exchange. Fees are payable in March and September 2025.
